

## UMFC Family Relationship Services - Fee Schedule

### Family Relationship Centre – Family Dispute Resolution (FDR)

**FDR Children’s Matters - \$30 per person for 2 hour session**

includes intake and assessment, information session, pre FDR, FDR, preparation of agreements and relevant correspondence

**Child Inclusive Practice - \$60 pp**

includes child appointments and parent feedback session

Waiver applies for Health Care Card or Concession Card holders or if annual income is less than \$50,000

Fees payable at the FDR stage

Cash, cheque (payable to “Upper Murray Family Care Inc”) or direct deposit. No EFTPOS facility

**FDR Property Matters\* - \$200 per person for 5 hours of service,  
after that, \$40 per person per hour**

\*eligibility criteria apply for property matters; discuss with the Service

No exemptions or waivers apply

Fees payable at Intake stage

Cash, cheque (payable to “Upper Murray Family Care Inc”) or direct deposit. No EFTPOS facility.

## Parenting Orders Program (POP) & Post Separation Family Counselling

### Parent's full program - \$140 per person

can include intake and assessment, information session, parent counselling, work with children and six week group work "Building Better Bridges" - (up to twelve months service)

### Children's Group Work - \$30 per child for 6 week group

includes intake and assessment, post group work feedback to parents, 6 week group work "Jigsaw" for children and all group work materials

### Individual Counselling sessions for parents - \$30 per person per session

can include intake and assessment, information session, parent counselling and work with children

### Child Inclusive Practice - \$60 pp

includes child appointments and parent feedback session

Waiver applies for Health Care Card or Concession Card holders or if annual income is less than \$50,000

Fees payable before Intake stage

Cash, cheque (payable to "Upper Murray Family Care Inc") or direct deposit. No EFTPOS facility.

## Children's Contact Service

### Supervised Contact - \$75 per person for six months of service

### Changeovers - \$75 per person for twelve months of service

includes intake and assessment, information session, child orientation and six months (supervised) or twelve months (changeovers) of service

Waiver applies for Health Care Card or Concession Card holders or if annual income is less than \$50,000

Fees payable before Intake stage

Cash, cheque (payable to "Upper Murray Family Care Inc") or direct deposit. No EFTPOS facility.

### Other

Subpoena of case notes - \$70 per subpoena (cheques to "Upper Murray Family Care Inc")

Reports (summary of CCS attendances) - \$400 per report

Attendance at Court (if required) - \$475 per half day, \$697 per full day,  
plus travel and accommodation if required

### Notes:

- Families using both CCS and POP concurrently will receive POP at 50% ie \$75 CCS + \$70 POP = \$145
- UMFC will not refuse service if payment causes financial hardship – discuss with your practitioner
